## **Acceptance of the Terms of Use**

These terms of use are entered into by and between the user ("you") and North American Hardware and Paint Association ("NHPA," "we," or "us"). The following terms and conditions ("**Terms of Use**") govern your access to and use of the NHPA Retail Marketplace, including all content, functionality and services (the "**Marketplace**"), whether as a guest or a registered user.
