This active shooter training course helps empower employees to anticipate and recognize an active shooter/threat situation and respond appropriately and immediately if they are ever faced with one. Helps you meet OSHA forklift training requirements while keeping both operators and pedestrians around forklifts safe. It is also useful for new or refresher forklift safety training in the event of an incident or near-miss, poor evaluation, or changes in the workplace or type of forklift used.

**NOTE:** This course helps you fulfill the classroom and practical OSHA forklift training requirements of 29 CFR 1910.178(I). Additional training may still be required to meet OSHA requirements.

#### Forklift Training: Refresher\*

**Audience**: New or veteran employees who use forklifts

Length: 20 minutes

Cost: \$25/per person

This course offers refresher training designed to reinforce the key concepts that help forklift operators stay safe while at work. Employees completing the program will be able to assess their forklift's limitations and work within those parameters, evaluate a forklift's readiness through proper pre-use inspections, operate a forklift safely and avoid potential hazards and maintain a forklift by recharging and/or refueling when necessary and reporting any defects.

### Hot Work: Safety Operations Training

**Audience**: Employees engaged in hot work

Regulations Covered: 29 CFR 1910.251

- 255, Subpart Q, and NFPA 51B

According to OSHA, hot work is defined as any work that involves burning, welding, using fire- or spark-producing tools, or that produces a source of ignition. Because of the potential dangers associated with hot work, it is critical everyone involved understands their role in keeping themselves and others around them safe from harm. This program is designed to guide employees directly involved in hot work operations through the hot work process, helping to prevent injuries and damage to facilities. Specifically, it covers the basics of hot work, how to prepare for and protect yourself and others during hot work operations, and what to do after the job is complete.

# Lockout/Tagout: Put a Lock on Hazardous Energy (with EyeCue)

Audience: Employees working in an area where machines may be locked out or tagged out for any reason

Length: 60 minutes

**Regulations Covered**: Helps satisfy 29 CFR 1910.147

OSHA's Control of Hazardous Energy standard (29 CFR 1910.147) mandates training, inspections, and recordkeeping to ensure that workers will not be injured by unexpected start-up or release of energy from a machine or piece of equipment during service or maintenance. Whatever your role in lockout/tagout, you need to

understand the reasons for lockout/tagout and know the established procedures. This course is designed to raise your awareness about the importance of lockout/tagout and teach you both when and how to follow the procedures every time they're needed.

### Reasonable Suspicion Testing: What Supervisors Need to Know

**Audience**: All persons designated to supervise CMV drivers

Length: 90 minutes

**Regulations Covered**: Helps comply with 49 CFR 382.603

Section 382.603 requires that all persons designated to supervise drivers receive at least 60 minutes of training on alcohol misuse and an additional 60 minutes of training on controlled substances use. This required training is used by supervisors to determine whether reasonable suspicion exists to require a driver to undergo testing under Sec. 382.307.

To satisfy the complete ELDT training requirements, the school or entity conducting the training must provide the driver-trainee "behindthe-wheel" instruction in addition to theory instruction.
